The 1st External Workshop “Future Sky Safety: a Joint Programme for Aviation safety” is dedicated to emerging safety issues and trends and to updates on the latest research developments. Attendance to the workshop is free.

A poster session will be open to students, researchers and projects willing to have an excellent opportunity to share their research with their peers and the aviation community.

The key theme throughout the workshop is Aviation Safety.

Submissions are welcome on the following topics:

Runway excursion

Systems and methods for risk prevention and mitigation

Organisational safety

Human error and human performance in aviation

Risk of fire, smoke and fumes

POSTER EXHIBIT SPECIFICATION

Posters should be designed for vertical orientation and should be exactly a 0.7m wide x 1m high space. In designing the poster, you must follow the guidance below: posters that do not meet the specification cannot be accepted.

POSTER LAYOUT GUIDANCE

INSERT:

- Poster title;
- Project logo (if existing);
- Maximum of 3 images of high quality, checking copyrights;
- 2 text boxes illustrating the topic or the project, each a maximum of 100 words in font size 45.

SUBMISSION OF ARTWORK

Artwork must be high resolution, supplied at 25% finished size (formatted for print in A4 size: 21cm x 29.7 cm).

KEY DATES AND DEADLINES

Poster Submission:

The deadline is Friday **10 February 2017** at **5:00pm** (BST), and is considered final once submitted.

Authors notification:

You will be notified via email when your proposal has been received. Acceptance or rejection of your proposal will be notified with another e-mail by **24 February 2017**.

- Applicants agree to comply with all rules and decisions of the jury.
- Poster submissions should include:
 - › Name
 - › Contact information
 - › Institution
 - › Poster title
 - › Topic the poster is linked to
 - › Poster description (250 – 500 words; e.g. it may include needs assessment, objectives, method, approach, outcomes, recommendations, etc.)
 - › All work must be written and presented in English.
- Posters must be submitted electronically in pdf to **m.amato@cira.it**. If accepted, posters must be printed by the author(s).

Competition Guidelines

The posters will be evaluated according to four criteria:

- 1) Originality
- 2) Scientific quality
- 3) Clearness
- 4) Coherence with one of the Future Sky Safety technical projects.

Finalists are expected to attend the workshop and deliver a short presentation on their work.
